Illinois Trust (the "Trust") is designed to address the shortterm cash and investment needs of municipalities, park and school districts and other local governments.

INVESTMENT OBJECTIVE

To earn the highest income consistent with preserving principal and maintaining liquidity, and to maintain a stable \$1.00 net asset value ("NAV").

ILLINOIS PORTFOLIO

A short-term liquid portfolio and cash management vehicle rated AAAm⁴ by S&P Global and permitted as an investment for all local governments pursuant to the Illinois Public Funds Investment Act, 30 ILCS 235/1 et seq.

TERM PORTFOLIO

A fixed-rate, fixed term portfolio rated AAAf by Fitch Ratings⁵ and permitted as an investment for all local governments pursuant to the Illinois Public Funds Investment Act, 30 ILCS 235/1 et sea.



This resulting net change is then annualized by multiplying it by 365 and dividing it by the number of calendar days in the month.


